TRUSTEES' REPORT FOR THE YEAR ENDED 31 DECEMBER 2017

The Trustees (who are also directors of the charity for the purposes of the Companies Act) present their annual report together with the financial statements of Association for Industrial Archaeology (the company) for the year ended 31 December 2017. The Trustees confirm that the Annual Report and financial statements of the company comply with the current statutory requirements, the requirements of the company's governing document and the provisions of the Statement of Recommended Practice (SORP), applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015), as amended by Update Bulletin 1 (updated 2 February 2016).

Since the company qualifies as small under section 383, the strategic report required of medium and large companies under The Companies Act 2006 (Strategic Report and Director's Report) Regulations 2013 is not required.

Objectives and Activities

a. Policies and objectives

The objects for which the Association is established are to encourage and promote for the public benefit the study of, and research in, the archaeology of industry and the industrial period, and to promote education in the identification, recognition and conservation of the industrial heritage.

Structure, governance and management

a. Constitution

The Association for Industrial Archaeology is registered in England as a charitable company limited by guarantee, under the Companies Act 1948 (no 1326854) and the Charities Act 1960 (no 277511). The company was established under the Memorandum of Association which established the objects and powers of the charitable company and is governed under its articles of association. In the event of the Association being wound up the members are liable for payment of the debts and liabilities of the Association and of the costs, charges and expenses of winding up. Each member is liable for such amount as may be required not exceeding £1.00.

b. Method of appointment or election of Trustees

The Council of Management is responsible for the appointment of Trustees, as a member of the Council, who are elected and co-opted under the terms of the Articles of Association.

Meetings and Representation

Council Meetings

In 2017 the AIA Council met three times: Leicester in March, London in June and a 2-day meeting was held in Coalbrookdale in October. Extracts of the meetings were posted on the AIA website and reported in *IA News*.

Due to a computing error at Taylor &Francis's end we discovered that 70 members who assumed they had paid at the beginning of the year still showed up on the database as 'lapsed'. Considerable efforts were made to rectify this and in February the AIA Secretary wrote to all of them, as a result of which 45 of them re-joined successfully, though 22 resigned, the remaining three having sadly died in the meantime.

The Secretary fielded 25 Restoration Grant applications which mostly arrived just days before the closing date of 31st March, and forwarded them to the Panel. In former years, Mark Sissons took the lead in rating all the applications to provide ranking guidance, but with Mark indisposed this year Keith Falconer undertook this task. Given the size of the grants Council's approval was sought for the selection at the June meeting in London. Details of the decisions are given later in this report.

In March the Council had begun to look at the long-term future of the Association, which resulted in a discussion meeting on the 6th October facilitated by heritage consultant John Batchelor. Council examined what we do (and what we don't do) who we do it for and why we do it. We also looked at what had changed since we were established, and whether our Aims are likely to attract a younger membership. Council considered the question: If the AIA ceased to exist, what impact would its loss have on wider society?' The meeting was remarkably consistent in its replies, namely that society would lose our role as advocates for industrial archaeology and our knowledge base. A new mission statement resulted from the discussions laying greater emphasis on our advocacy role, and over the coming months we will consider how best to develop it: We use and develop our knowledge and expertise in the most accessible ways possible to advocate the value of industrial heritage / archaeology and help others (i.e. the public) to do so.

Council is grateful to Steve Dewhirst for scanning 23 gazetteers and 18 sets of tour notes, which are now freely available on the web site. In October the Association agreed a new publishing agreement with Taylor & Francis which would see the printing of *IA News* being done by Routledge.

On a poignant note we received a legacy of £15,000 from the executors of the late Patrick Nott, a long-standing member who died shortly after attending the 2016 Annual Conference in Telford.

Representation

Council members also represent the AIA and industrial archaeology matters in other groups and committees regionally and nationally to promote the Objects of the Association. Below are some of the key positions they held during the year.

Prof. Marilyn Palmer our President, is on the National Trust Historic Environment Panel as a Specialist Advisor; Chair of Trustees on the Council for British Archaeology; she chairs the East Midlands CBA committee; is on the National Railway Heritage Awards committee; on the Leicestershire Industrial History Society as Vice President; on the committee of the Leicestershire Archaeological & Historical Society; chairs the Trustees of their Research Fund; represents AIA on the Heritage Alliance; Marilyn is also the Subject Advisor for Archaeology to the Third Age Trust.

Keith Falconer the AIA Chairman until 27th August 2017, is on the All Party Parliamentary Group (APPG) on the Industrial Heritage; on the Industrial Heritage Support Officer steering group; on HLF's Industrial Maritime & Transport Group; member of the Canal & River Trust Heritage Advisory Group; on the European Route of Industrial Heritage UK group; consultant to Historic England on the heritage of navigable inland waterways; and a Visiting Research Fellow at the History of Technology Research Unit at the University of Bath.

<u>Dr Michael Nevell</u> the Vice Chairman until the AGM in August and then Chairman, is on Historic England's Expert Advisory Group; trustee of CBA and Chair of the CBA North West Industrial Archaeology Panel; and until April was Chair of the CIfA Buildings Archaeology Group.

Mark Sissons sadly had to give up his roles over the year as an incurable illness took over, forcing him to resign in November. He died in February 2018. For part of the year he was on the CBA National Listed Buildings panel; on the Heritage Railway Association and as Archivist to them; on the North York Moors National Park archaeological panel; and both a director of, and archivist to, the North York Moors Historical Railway Trust.

John Jones the Honorary Treasurer, is Records Officer of the Suffolic Industrial Archaeology Society; and Honorary Treasurer of the East of England Regional Industrial Archaeology Conference.

<u>Dr Robert Carr</u> represents AIA at the AGM of the Heritage Alliance and at the AGM of the British Archaeological Awards; on the Newcomen Society; the Greater London Industrial Archaeology Society; and the AIA representative on TICCIH-GB.

<u>Tony Crosby</u> is on the All Party Parliamentary Group (APPG) on the Industrial Heritage; and on the Essex Industrial Archaeology Group as Chairman.

<u>lan Miller</u> is a member of the Industrial Archaeology Committee of the Cumbria & Westmorland Antiquarian and Archaeological Society; and a member of the CBA North West Industrial Archaeology Panel.

Roy Murphy is Chairman of Droitwich History and Archaeology Society; Councillor of Droitwich Town Council; and District Councillor of Wychavon District Council. He represents the AIA at regional Industrial Archaeology conferences.

Amber Patrick the Planning Casework Officer, is on the Council of the Gloucestershire Society for Industrial Archaeology; and coordinator of the Maltings Special Interest Group of the Brewery History Society.

<u>Kate Dickson</u> is the AIA Liaison Officer on E-FAITH; she is a trustee of the Architectural Heritage Fund; a Heritage Lottery Fund mentor; Membership Assessor and member of the Membership & Ethics Committee of the Institute of Historic Building Conservation; and Chair, Midlands Regional Committee, of the Heritage Trusts Network.

Mark Watson is the UK representative of the International Committee for the Conservation of the Industrial Heritage (TICCIH); Convenor of the Institute of Historic Building Conservation (IHBC) Scotland branch; he sits on the ICE Engineering History & Heritage Editorial Advisory Panel; the Institution of Engineers & Shipbuilders in Scotland Hall of Fame judges panel; on committees of the Scottish Industrial Heritage Society (SIHS), the Scottish Vernacular Buildings Working Group (SVBWG), and the Scottish Transport & Industry Collections Knowledge Network (STICK).

Shane Kelleher is a trustee and Secretary of the Birmingham Conservation Trust; on the Archives and Collections Committee; and on the Archaeology Committee of the Historical Metallurgy Society.

Lobbying, Advocacy and Communication

The future of Helmshore Mills Textile Museum and Queen's Mill in Burnley remained uncertain and a sustained effort was made by Sir Neil Cossons, the President, the Chairman and others to get the local authority to provide funding. The Newcomen Society, the National Trust and the Victorian Society supported the lobbying. The Association also nominated Queen's Street Mill to the World Monuments Watch which in turn informs nominations for Europa Nostra's Most Endangered Site'. Whitechapel's grade II* listed Bell Foundry was also under threat of closure and the Association supplied evidence.

Under the new title of 'Planning Casework Officer' Amber Patrick reviewed about a hundred potential cases involving the demolition or major conversion of industrial buildings and sites during the year. Comments were made on 25 cases. These included: Beehive Mills in Bolton; Cardiff Bay Station; the former Marconi site in Chelmsford, Essex; Fussell's ironworks in Mells, Mendip; Mutual Mills, Rochdale; the Victory Arch, Consett, County Durham; the demolition of the chimneys at Stewartby Brickworks, Bedfordshire; Rutland Mills, Wakefield; gas holders at Greeenwich Peninsula and the Oval, Kennington; Mutual Mills, Heywood, Rochdale; the severely fire damaged Newsome Mills in Huddersfield; Hollins Mill in Todmorden and Croft End Mill in Stubbins. There were also comments on the Whitechapel Bell Foundry, malthouses in Bishops Stortford, Kimberley, Nottinghamshire and Banbury Oxfordshire. Appeals were made on Chance's Glass Works in Smethwick and on the Waltham Abbey Royal Gunpowder Mills.

Tony Crosby represented the Association at two of the HLF's Industrial, Maritime and Technology group meetings, where the Fund's officers are informed of the issues within the sector and how grants might be best directed to support this. The first was on board the Medway Queen, Gillingham Pier, in June. The Association of British Transport and Engineering Museums through their consultants, the International Railway Heritage Consultancy, have been commissioned to up-date the guidelines on Larger and Working Objects, due for publication in early 2018. HLF recommended a Resilient Heritage grant programme to support organisational sustainability in a strategic manner. A further meeting was held at the London Museum of Steam & Water in December attended by Tony Crosby and Shane Kelleher. The launch of the European Year of Cultural Heritage 2018 (EYCH) took place on the same day and several AIA events will be badged accordingly. Consultation on various HLF initiatives were announced to come on stream in 2018 and 2019. However, the HLF grant budget for 2018 will be £190m, a lower amount than in recent years.

The All Party Parliamentary Group (APPG) on the Industrial Heritage had planned an Evidence Session on 27th April, but this was abandoned as Parliament went into recess due to the imminent General Election. They met again on 18th July to be reconstituted in 2017. Following this there were two Evidence Sessions on 11th and 12th October when representatives from various heritage bodies made brief presentations to MPs and Peers about the 'three main challenges faced by industrial heritage'. AIA was among them, represented by Sir Neil Cossons, Marilyn Palmer, Mike Nevell, Ian Miller and Keith Falconer. The others who addressed the APPG were Historic England, Historic Environment Scotland, RCAHMW, the Architectural Heritage Fund, the Heritage Lottery Fund, the Canal & Rivers Trust, the Heritage Railway Association, Chatham Dockyard, Big Pit, Ironbridge Gorge Museum and Sheffield Industrial Museum. However, as in 2016, the number of MPs and Peers attending the APPG remains small and we urge all AIA members to encourage their local MPs to take an active part in this group and thereby raise the profile of industrial heritage.

AIA Practical Day

This year's event took place at the Ironbridge Gorge World Heritage Site on 8th April. The day, which was titled 'Forging Ahead: Understanding the Iron Industry', was led by the archaeologist and author Richard Hayman, formerly Archaeologist at the Ironbridge Gorge Museum Trust, with the assistance of AIA Council members Steve Dewhirst, Ian West, John Powell and Shane Kelleher. Mike Nevell introduced the day and outlined the work and remit of the Association before introducing Richard Hayman, who provided an excellent introduction to the processes, buildings and landscapes of the historic iron industry. The main element of the day consisted of a walking tour of the Ironbridge Gorge taking in the key iron production and related sites in the area including: the OId Furnace, the Upper Forge, the site of the earliest known steel cementation furnace, the AGA foundry, and the early forge at Dale End. A picnic lunch at Bedlam Furnaces followed a tour of the Iron Bridge by David de Haan, before the group moved on to look at the engine house at Lloyds Coppice, and finish the tour at the Blists Hill Blast Furnaces. 23 people were in attendance, 10 of whom were not AIA members or students.

Annual Conference

It was held at Moulton College, Northamptonshire from 25th to 30th August. At the Friday Seminar on Developer-funded projects presentations were given on the National Planning Policy Framework, Enderby Wharf in Greenwich, Swansea's copper and zinc smelting works, the M74 in Glasgow, King's Cross Goods Station, and pumping stations in Wessex.

The following day there were lectures on Northamptonshire's boot and shoe industry, on the National lift tower, onion barns and the Bedfordshire brick industry, followed by contributions from seven members, reports from the recipients of awards, and the annual dinner. Following the AGM on 27th August attended by 77 members and guests Nigel Crowe gave the Rolt Memorial Lecture on The Grand Union Canal. On subsequent evenings there were lectures on the Leighton Buzzard Light Railway and on the Wolverton Railway Works.

During the conference there were visits to Harrington Aviation Museum, Northampton's boot and shoe quarter, Rushden Transport Museum, the Shuttleworth Collection of aircraft, the Leighton Buzzard Light Railway, Bletchley Park, Stoke Bruerne Canal Museum and Blisworth Tunnel, Weedon Royal Ordnance Depot, Wolverton Railway Works, the Milton Keynes Museum, the National Lift Tower and Church's Shoe Factory. A full illustrated report appeared in the winter edition of *IA News*.

Full credit must go to our Conference organising team of Marilyn Palmer and David Ingham and for the excellent support from John McGuinness and Steve Miles. Our thanks also go to the many host organisations for their involvement with the study visits.

Publications

<u>IA News</u>: This quarterly is the bulletin and main communication organ of the AIA. Four issues under the editorship of Chris Barney were published by the Association in 2017, which continues to encourage high standards in all aspects of the study of industrial archaeology. Illustrated reports covered all the Association's activities as well as short technical articles, reports on the work of the AIA Council, affiliated societies, restoration grants, regional news, international news, visits, conferences, letters, etc. Highlights during 2017 included illustrated reports on the threatened cotton mills of Lancashire – Queen Street Mill in Burnley and Helmshore Mills Textile Museum; Sandfields Pumping Station in the Black Country; on the future of Industrial Archaeology societies; Woolwich Arsenal; and an update on Restoration projects.

<u>IA Review</u>: Peer reviewed and with an international Editorial Board, the journal of the AIA edited by Dr Michael Nevell and Dr Ian West was published for the Association by Taylor & Francis. The May issue, Volume 39.1, contained papers on: Defining the Vintage Car – LTC Rolt and Vintage Sports Car Club and the Rise of Motoring Heritage (the Rolt Lecture 2015); The Roads of Andalusia and Valencia; Mineral Loading Docks in Rande Strait, North-Western Spain; Lime Burning in Clamp Kilns in Scotland's Western Central Belt; and Lion Salt Works, Northwich.

The November issue, Vol 39.2, was delayed and did not appear in print until February 2018, though some of the papers were available on-line during 2017. This was dedicated to Workers' Housing, including articles on Manchester; Back-to-back Housing in Leeds; Cotton Workers' Accommodation in the Derwent Valley; Workers' Affordable Housing and the Development of Construction Systems.

Later in the year Ian Miller replaced Mike Nevell as co-editor and Rebecca Haslam, Senior Post-excavation Archaeologist for Pre-Construct Archaeology in London, was appointed to a new post of Assistant Editor.

Awards

To encourage scholarship and investigation in the industrial archaeology field, awards were made to archaeologists, historians, professionals and students:

- 1. The winners of the Peter Neaverson Award for Outstanding Scholarship were Marilyn Palmer and Ian West for *Technology in the Country House*.
- 2. The Voluntary Societies Publication Award went to Philip Tolley (editor), Norfolk Industrial Archaeology Society, for Norfolk 1890.
- 3. The Commercial Publications Award went to Michael Nevell, Andrea Smith and Frank Meddens (editors) for *The Birth of Industrial Glasgow: the Archaeology of the M74.*
- 4. The Archaeological Report Award went to Rebecca Haslam and Guy Thompson of Pre-Construct Archaeology for *An Immense and Exceedingly Commodious Goods Station* [King's Cross].
- 5. The Postgraduate Dissertation Awards went to Siobhan Osgood of Trinity College, Dublin, for *Railway Architecture*: The Great Northern Railway (Ireland) at Dundalk, and to Kristin Potterton of the University of York for Managing the Industrial Ruin in a national park.
- 6. The Dorothea Award went to Hayley Underwood and Phil Wright for the restoration of the steam engine at Middleport Pottery, Stoke.

Restoration Grants

In 2017 the Association received a further very generous amount from the same anonymous donor to support our Restoration Grants, and we were also thrilled to receive support from a second donor. Since this scheme began we are delighted to report that over half a million pounds have been allocated to restoration projects. New restoration projects and progress on the on-going ones were reported in greater detail to the annual conference in August and there was widespread support for them. As is usually the case with grants, the fund was heavily over-subscribed. This year there were 25 applications requesting total grants of £304,912 towards projects with a total value of £759,463. Eight awards were made totalling £122,000:

- 1. Beeleigh Mill Restoration Group: restoration of flooring of the 1795 corn mill at Maldon, Essex. £20,000.
- Ferryhill Railway Heritage Trust: replacement of timbers to the 1905 railway turntable at Ferryhill, Aberdeen, £20,000.
- 3. Lakeland Arts: restoration of the engine and boiler of the c1895 steam launch 'Lady Elizabeth'. £20,000.
- 4. Britannia Sailing Trust: restoration of the 1915 sailing smack 'Britannia' at Gweek, Cornwall. £18,700.
- 5. Museum of East Anglian Life: restoration of a 1912 Burrell agricultural traction engine, the 'Empress of Britain' at Stowmarket, Suffolk. £16,500.
- 6. Helston Railway Preservation Society: restoration of the boiler and brakes of the 1949 Peckett locomotive William Murdoch' at Helson, Cornwall. £14,000.
- 7. Underfall Yard Trust: restoration of Victorian dock maintenance machinery at Bristol. £9,500.
- 8. Greensand Railway Museum Trust: replication of the roof for an armoured 1917 Motor Rail & Tram Car at Leighton Buzzard. £3,300.

Industrial Heritage Support Officer (IHSO)

Three years of further funding was secured from Historic England from April 2017, along with a contribution from the AIA. In May Shane Kelleher was re-appointed as the Officer until 2020, but left the post in December. Key outputs in 2017 have included:

- Provision of advice, information and support to 22 organisations;
- Training, delivery and attendance by the Officer at 15 events
- The launch of the West Midlands Industrial Heritage Network at Coalbrookdale in March, and discussions for similar networks to be established for Greater London and Tyne & Wear.

Heritage of Industry' organized this 7-day tour with the assistance of Jur Kingma, which quickly sold out. A full report by John Copping appeared in the autumn issue of *IA News*. A Friday afternoon seminar in Utrecht on the topic of the adaptive re-use of industrial buildings was well received and attracted support from other industrial heritage organisations in the Netherlands and Flanders. Our thanks go to Council members Amber Patrick and Mark Watson who gave presentations at the event. Highlights of the tour included the magnificent Harvey & Co pumping engine at Cruquius Pumping Station, the windmills at Kinderdijk, a boat trip to Rotterdam and visits on board two preserved ships – SS Rotterdam and HMS Elfin.

Country House Comfort & Convenience

In this continuing series of specialist tours organized by 'Heritage of Industry' four tours ran during the year. The first one was a repeat visit to the Welsh Borders in April led by Ian West. The other three were led by Marilyn Palmer: to the South West in June; to Northern Ireland in August; and to the North East in September. All were fully booked.

Results

The net deficit for the year amounted to £1,098, with a deficit of £9,916 attributable to restricted funds, £15,000 surplus to designated funds and a deficit of £6,182 attributable to unrestricted funds (2016: net deficit of £80,597, with £80,087 attributable to restricted funds and £510 attributable to unrestricted funds).

Reserves policy

The policy remains unchanged from 2016 whereby Council maintains a contingency for a late cancellation of the annual conference, for a cancellation of an issue of *Industrial Archaeology Review*, and for a sufficient reserve to cover cash flow fluctuations during the year. The Council considers that a reserve of not less that £60,000 is required.

That was particularly valuable in the first half of the year when due to the terminal illness of the Secretary's wife Council members shared much of his workload. Thanks are especially due to John Jones, Keith Falconer and Ian West.

NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED 31 DECEMBER 2017

1. Accounting Policies

1.1 Basis of preparation of financial statements

The financial statements have been prepared in accordance with Accounting and Reporting by Charities: Statement of Recommended Practice applicable to charities preparing their accounts in accordance with the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) (effective 1 January 2015) - (Charities SORP (FRS 102)), the Financial Reporting Standard applicable in the UK and Republic of Ireland (FRS 102) and the Companies Act 2006.

The financial statements have been prepared to give a 'true and fair' view and have departed from the Charities (Accounts and Reports) Regulations 2008 only to the extent required to provide a 'true and fair' view. This departure has involved following the Charities SORP (FRS 102) published on 16 July 2014 rather than the Accounting and Reporting by Charities: Statement of Recommended Practice effective from 4 April 2005 which has since been withdrawn.

Association for Industrial Archaeology meets the definition of a public benefit entity under FRS 102. Assets and liabilities are initially recognised at historical cost or transaction value unless otherwise stated in the relevant accounting policy.

1.2 Company status

The company is a company limited by guarantee. The members of the company are the Trustees named on page 1. In the event of the company being wound up, the liability in respect of the guarantee is limited to £1 per member of the company.

1.3 Fund accounting

Unrestricted funds comprise accumulated surpluses and deficits on the unrestricted activities of the company. They are available for use at the discretion of the Trustees in the furtherance of the company's charitable objectives.

Restricted funds are created when grants or donations are made for a particular purpose, the use of which is restricted to that purpose. The costs of raising and administering such funds are charged against the specific fund. The aim and use of each restricted fund is set out in the notes to the accounts.

1.4 Incoming resources

Voluntary income is received by way of donations and gifts, and is included in full in the statement of financial activities when receivable.

Investment income is included when receivable.

Incoming resources from charitable trading activity are accounted for when earned.

1.5 Resources expended

Expenditure is recognised on an accrued basis as a liability is incurred. Expenditure includes any VAT which cannot be fully recovered and is reported as part of the expenditure to which it relates.

Governance costs include those costs associated with meeting the constitutional and statutory requirements of the Charity and include the accountancy fees and costs linked to strategic management of the charity.

Costs of generating funds comprise the costs associated with attracting voluntary income and the costs of trading for fundraising purposes.

Charitable expenditure comprises those costs incurred by the Charity in the delivery of the activities and services for its beneficiaries. It includes both costs that can be allocated directly to such activities and those costs of an indirect nature necessary to support them.

All costs are allocated between the expenditure categories of the SoFA (Statement of Financial Activities) on a basis designed to reflect the use of resource.

Grants payable are charged in the year when the offer is made except in those cases where the offer is conditional, such grants being recognised as expenditure when the conditions attaching are fulfilled. Grants offered subject to conditions which have not been met at the year end are noted as a commitment, but not accrued as expenditure.

1.6 Debtors

Trade and other debtors are recognised at the recoverable amount.

1.7 Cash at Bank and in hand

Cash at bank and in hand includes cash and short term highly liquid investments with a short maturity of three months or less from the date of acquisition or opening of the deposit or similar account.

1.8 Liabilities and provisions

Creditors are recognised at their settlement amount after allowing for any trade discounts due.
